

IN THE CIRCUIT COURT OF THE MUNICIPAL DIVISION OF THE CITY OF DELLWOOD

COURT ORDER NO. 22

Pursuant to revised Missouri Statutes 479.050, and Rule 37.49 of the Supreme Court Rules of the State of Missouri, the undersigned Municipal Judge of the City of Dellwood, hereby orders that the following designated offenses shall be payable to the City of Dellwood Violations Bureau. In Such cases, no court appearance is necessary.

This schedule is divided into three parts, Part I consists of the Dellwood Municipal Division Uniform Traffic Violation Schedule, for moving violations (points). Part II consists of the Dellwood Municipal Division Uniform Traffic Violation Schedule, for non-moving violations. Part III consists of ordinance violations which can be paid out of court as imposed by the City of Dellwood.

In accordance with Missouri statutes and ordinances adopted by the City, total court costs shall be \$31.50. This includes Basic Court Costs of \$11.00, Judicial Education Fund of \$1.00 Crime Victim's Compensation Surcharge of \$7.50, Law Enforcement Training Fund of \$1.00, Peace Officer's Standard Training Fund of \$2.00, Biometric Verification System Surcharge of \$2.00, Statewide Court Automation Fund of \$7.00; for a total of \$31.50. Court costs shall be paid in addition to the fine.

Any municipal violation resulting in personal injury or property damage, including an automobile accident, requires a court appearance.

Any violations not specifically listed below, requires a court appearance.

**Speeding:**

Up to 14mph over limit: \$6.00 per mile (plus \$0.50), plus Court Costs\*

For 15-20mph over limit: \$7.00 per mile (plus \$0.50), plus Court Costs\*

For 21+mph over limit: \$8.00 per mile (plus \$0.50), plus Court Costs\*

Must come to court if charged with speeding more than 25 mph over limit.



It is further ordered that Jessica Clayton shall be designated the Clerk of the Court subject to the supervision of the Judge, and shall hold this appointment until a further order of the Court is appointed to the Dellwood Municipal Division.


It is further ordered that the Municipal Judge may add, consistent with the Supreme Court Rules, additional violations which may be paid at the Violations Bureau, and that all transactions of the Violations Bureau shall be considered transactions of the Court and regular court records shall be kept.

It is further ordered that Court Costs pursuant to the Ordinances of the City of Dellwood shall be collected on all moving and non-moving violations paid in the Violations Bureau.

In no event shall any traffic offenses involving property damage or personal injury, or offenses not above mentioned, be payable to the Violations Bureau.

It is further ordered that all summonses issued by NORTH COUNTY POLICE COOPERATIVE ON DELLWOOD DETAIL shall indicate a court date for appearance by the Defendant. Should the summons entail a violation which is payable through the Violations Bureau, the Officer shall so inform the defendant and shall instruct the Defendant that he or she may forward payment by mail in the special Mail-In envelope, call or pay online through nCourt 1-800-701-8560 (fees apply) or pay in person at the City Hall, temporarily relocated to 10266 West Florissant Avenue. Failure by the Defendant to pay violation through the Violations Bureau prior to the assigned court date, shall necessitate a court appearance.
